## Paige Holds Meeting with School Superintendents, Board Members From Nation's Largest School Districts

U.S. Secretary of Education Rod Paige recently met with school superintendents and school board members from some of the nation's largest school districts as part of his new *Partnership to Leave No Child Behind*. The meeting was an opportunity for Paige and his staff to outline many of the elements of the newly reauthorized Elementary and Secondary Education Act, and to hear comments and suggestions from local school leaders. Last month, Paige hosted a similar meeting with state education chiefs in Alexandria, VA.

Leaders from the following systems attended: Atlanta Public Schools; Birmingham City Schools; Broward County Public Schools; Buffalo City School District; Charlotte-Mecklenburg Schools; Chicago Public Schools; Clark County School District; Columbus Public Schools; Dayton Public Schools; Denver Public Schools; and Detroit Public Schools. In addition, District of Columbia Public Schools; Fresno Unified School District; Fort Worth Independent School District; Guilford County Schools; Houston Independent School District; Jefferson County Public Schools; Milwaukee Public Schools; New York City Board of Education; Norfolk Public Schools; Oklahoma City Public Schools; Omaha Public Schools; Orange County Public Schools; Philadelphia Public Schools; Pittsburgh Public Schools; Richmond Public Schools; Rochester City School District; Seattle Public Schools; Toledo Public Schools.

Under the new law, states and school districts will develop strong systems of accountability based upon student performance. The measure also gives those states and school districts increased local control and flexibility in exchange for delivering academic results. ## **Teacher Quality Requirements Pose Problems for Voc Ed**

Vocational education administrators nationwide are concerned with a new teacher quality requirement in the "No Child Left Behind Act of 2001." The new federal K-12 education law requires all teachers who teach in core areas to hold at least a bachelor's degree by the 2005-2006 school year. However, under certain circumstances, this requirement could be a huge obstacle to overcome in the career and technical education field. As a result, schools could be forced to eliminate courses that rely on teachers who do not have degrees but are highly qualified in their trade. The Department of Education said it hopes to address this issue soon.

## **New Director Appointed to Head Office of Special Education Programs**

Bob Pasternack, Assistant Secretary of the Office of Special Education and Rehabilitative Services, has announced the appointment of Stephanie Lee to be the Director of the Office of Special Education Programs (OSEP). In a prepared statement, Pasternack said:

Stephanie comes to OSEP after serving as a consultant and government affairs representative to the National Down Syndrome Society. Over the past 30 years Stephanie has worked extensively and collaboratively with various national organizations, congressional members and staff, as well as various parent advocates to affect disability policy and legislation at the Federal and State levels. As a parent of a child with a disability, Stephanie has a personal understanding of the complex array of issues and challenges facing special education, particularly as we move to the upcoming reauthorization of IDEA. She played a major role in the 1997 reauthorization of IDEA by actively working with national organizations and members of Congress throughout all stages of the reauthorization process. Her experience will be invaluable as we work on behalf of the administration to achieve improved outcomes and results for infants, toddlers, children, and students with disabilities.

## **New ECS Report Explores What ESEA Means for States**

In response to President Bush signing into law the revised Elementary and Secondary Education Act (ESEA), the Education Commission of the States (ECS) has released a new publication designed to help state leaders understand what the new law will mean for them. The report is entitled "No State Left Behind—The Challenges and Opportunities of ESEA 2001." The new report:

- Summarizes the new law
- Looks at where the states stand in regard to ESEA requirements
- Provides questions for policymakers to consider when deciding how to respond to ESEA.
